4.1 <u>National Competency Standards for General Dentists</u>

Dr. Gerrow reported that the Working Group on National Competency Standards for General Dentists circulated a draft document to Board members at the meeting of August 20, 2021 for review and feedback. Since that meeting, the Working Group met and reviewed the comments received from the Board, as well as from the National Dental Examining Board of Canada (NDEB) and from the Association on Canadian Faculties of Dentistry (ACFD).

He added that a revised draft has been prepared and would be shared with the Academic Deans for their feedback. It will then be brought back to the CDRAF Board before being widely distributed to stakeholders. It is anticipated that it will be near to completion by spring 2022.

6. CDRAF STRATEGIC PLAN

The CDRAF Board was provided with a copy of the modified Strategic plan for 2021-2022. Dr. Gerrow emphasized the importance for the Board to review the status of the Strategic Plan at each meeting. He referred to the Strategic Initiatives on page 6 of the document, specifically #1: "Develop national competency standards for general dentists and dental specialists."

There was discussion on the need for standards for dental specialists being more critical than ever because of the ongoing discussions around certification.

Dr. Dagenais advised that NDEB has started to work on competency profiles for each dental specialty. She added that the specialists in each specialty have yet to review the competencies and then they would be forwarded to CDRAF for circulation to dental specialists to validate the work.

She undertook to provide a draft copy of the competency profiles to include as resources for the CDRAF Board meeting of October 30, 2021, but requested that the document not be widely circulated to anyone other than DRAs.

Dr. Gerrow referred the CDRAF Board to the statement in the Strategic Plan: "To embrace and promote standards with regard to cultural safety and humility." He encouraged Board members to work with him and Dr. Hacker in ensuring this is adhered to on the agenda for each meeting.

A copy of the by-laws was provided for information and reference.

8. CDRAF REPRESENTATIVES AND OBSERVERS AT OTHER MEETINGS

Dr. Gerrow reported that the NDEB Annual General Meeting will be held in Ottawa on October 23, 2021. As the meeting will be held in-person, he will attend as CDRAF representative.

Dr. Auyeung advised that the CDAC Dentistry Committee is scheduled to be held on December 16, 2021 and the CDAC Board meeting will be held on December 17, 2021.
