1. CALL TO ORDER

Ms. Daoust called the meeting to order at 11:00 am EDT. She presented a

Ms. Daoust invited Board members, member representatives and representatives of other organizations to introduce themselves and welcomed them to the meeting.

2. APPROVAL OF AGENDA

There were no revisions made to the agenda circulated.

3. REVIEW OF MINUTES

The minutes of the CDRAF Members' Representatives meeting of October 15, 2021 were previously circulated and approved electronically, and were provided for information.

4. REPORT FROM BOARD OF DIRECTORS

Ms. Daoust presented the Report from the Board of Directors. There were no questions on the report.

She advised that Health Canada sent dental regulators an invitation to attend a Canada Dental Benefit Technical briefing on October 25 and 26. She reminded members to contact Health Canada directly with their contact information if they wished to participate in the briefing.

Dr. Gerrow reported that he was invited by the Bristol Dental School at Bristol University, UK, to discuss accreditation in Canada and reciprocal agreements with Ireland, Australia and New Zealand. He had preliminary discussions with the Manager of Curricula Review and Development and there may be follow-up questions. Dr. Gerrow recommended that the General Dental Council contact the Commission on Dental Accreditation of Canada for further information on reciprocal agreements.

5. CDRAF STRATEGIC PLAN

Dr. Gerrow reported that the CDRAF Board met in Montreal on August 18, 2022 for a full-day session to develop the strategic plan for 2023-2026. He reported that following a fulsome discussion, a draft plan was developed and would be reported on at the CDRAF Board meeting (following the CDRAF Members' meeting) and discussed whether stakeholder consultation will be required before final approval.

6. FINANCE

(a) Treasurer's Report

Dr. Misra presented the report. He stated that at the CDRAF Board meeting of August 19, 2022, the Board approved an operating fee for 2023 of \$12.00 per member. The increase will offset the current inflationary environment, while providing a small amount of additional funds for the Restricted Fund and prepare for a potential increase of inperson internal and external meetings.

A copy of the Policy on Internally Restricted Net Assets was provided for information.

(b) Financial Statements, December 31, 2021

The CDRAF financial statements, as at December 31, 2021, approved by the CDRAF Board in April, were provided for information.

(c) Budget 2023

The CDRAF budget for 2023, approved by the CDRAF Board in August, was provided for information.

7. REPORTS

7.1 The National Dental Examining Board of Canada (NDEB)

Dr. Dagenais provided a written report for the Members and highlighted some of the key items.

- There were delays in delivery of the first virtual OSCE examination, but implementation is anticipated for March 2023.
- Prometric is not able to provide sufficient seating, but a new thirdparty technology company has been engaged to offer the exams in hotels and convention centres across the country.

7.2 Association of Canadian Faculties of Dentistry (ACFD)

Dr. Allison presented the ACFD written report and highlighted some of the activities.

- There are ongoing discussions re CDAC's governance and finance proposal.
- Implications for the dental schools of the new Federal dental program.

7.3 Commission on Dental Accreditation of Canada (CDAC)

Dr. Matthews presented the written report on the activities of CDAC.

- All accreditation survey visits postponed in 2020 were rescheduled and were completed virtually in 2021.
- A final report of the Governance Review Standing Committee (GRSC) will be presented to CDAC at its Annual General Meeting on November 14, 2022. Stakeholders have been asked to submit nominees for the various CDAC committees.

7.4 Office of the Chief Dental Officer of Canada (OCDOC)

Dr. Taylor reviewed the written Annual Report of the OCDOC from April 2021.

- Continue work with Health Canada on the Canadian Health Measures Survey.
- OCDOC commissioned a major project with the University of Toronto to undertake an Environmental Scan of Publicly Financed Dental Care in Canada, in collaboration with the 13 Provincial/Territorial Dental Directors.

7.5 Royal College of Dentists of Canada (RCDC)

Dr. Mason presented the written report from RCDC.

- The 2022 administration of the Fellowship Examination took place in May and June 2022.
- RCDC will work with NDEB for the administration of NDSE for 2024.
- A proposal has been presented to CDRAF for review and approval.

7.6 Canadian Dental Association (CDA)

Dr. Soucy presented a written report from April 2021-April 2022. He reported that since April 2022, there has been a shift in priorities from the management of COVID to the Federal Dental Plan.

7.7 Canadian Dental Specialties Association (CDSA)

Dr. Sharma presented a written report on CDSA activities.

- CDSA supports the delivery of NDSE by RCDC.
- Continue dialogue with CDSPI regarding retired members' malpractice insurance.
- There has been a vigorous debate regarding a national specialty in dental anaesthesia, but no consensus amongst members. Each specialty organization was directed to provide their own comments.
